THIS MATTER, Having come before the Court as a supplemental proceeding in conjunction with the Order for the organization of the Costilla County Conservancy District, said Order entered in open Court on May 24, 1976, and the Court having noted that it was ordered that Maclovio Martinez, Elmer Valdez and Ernest Barela were appointed Directors of said Conservancy District for the terms of five, three and one year respectively, and pursuant to C.R.S. 37-3-101, the terms should have been for five, three and two years, respectively.

THEREFORE, IT IS ORDERED That Ernest Barela shall be appointed Director of said Conservancy District for a term of two years instead of a term of one year and that in all other respects the Order of May 24, 1976, shall remain in full force and effect.

IT IS FURTHER ORDERED That each of said Directors, Maclovio Martinez, Elmer Valdez and Ernest Barela, and each successor of any of those Directors, after being duly appointed and qualified as successor, shall furnish a corporate surety bond, at the expense of the Costilla County Conservancy District, in the amount of \$2,500.00 each, conditioned upon the faithful performance of each individual as his duty as Director, and that the bond or a copy thereof shall be included in the Court file.
